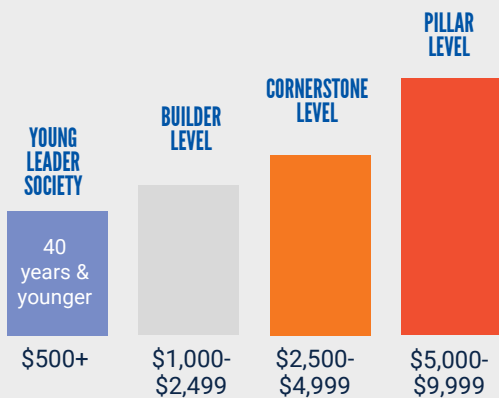
TOCQUEVILLE SOCIETY
